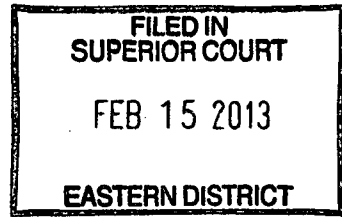

MOTION FOR APPROPRIATE RELIEF


Comes now Appellant William Lynn, by and through counsel, and moves this Court for an Order setting an expedited briefing schedule and in support thereof avers as follows:

1. On August 30, 2012, Appellant filed his statement pursuant to Pa. R. App. Pro. 1925(b).
2. On February 5, 2013, this Court entered an Order directing the trial court (Honorable Teresa Sarmina) to forthwith file her Opinion pursuant to §1925(a). As of the filing of the within Motion, the trial court's §1925(a) Opinion has not been filed.

3. Appellant remains incarcerated since June 22, 2012 on a single conviction of endangering the welfare of children (a single child)¹ in violation of 18 PA. C.S.A. §4304. He is unable to perfect his appeal until such time as this Court sets a briefing schedule, which normally occurs following the lower court's filing of a §1925(a) Opinion.

4. Appellant seeks an Order from this Court setting an expedited briefing schedule, notwithstanding the Court not receiving a §1925(a) Opinion from the lower court.
