**COMMONWEALTH'S MOTION FOR A 30-DAY
EXTENSION OF TIME IN WHICH TO FILE ITS BRIEF**

Appellee, the COMMONWEALTH OF PENNSYLVANIA, by its counsel, hereby respectfully moves the Court for a 30-day extension of time in which to file its brief in the above-captioned matter. In connection with this request, the Commonwealth now states as follows:

1. This is an appeal by a defendant convicted of various public corruption offenses which seeks review of the judgment of sentence imposed on June 19, 2012, by the Dauphin County Court of Common Pleas at No. CP-22-CR-4242-2009. On November 8, 2012, the trial court issued an order specifying the amount of restitution to be made in this case.

2. Appellant's notice of appeal to this Court was filed on December 10, 2012. She filed her brief on July 16, 2013, and served it upon appellee by first class mail the same day.

3. Appellee's brief is currently due on August 19, 2013.

4. Because of litigation-related responsibilities in other matters she is handling in the state and federal courts during the period allotted for appellee's brief, counsel for appellee requires additional time in which to prepare and submit appellee's brief in this matter.

5. Appellee respectfully requests a 30-day extension of time until September 18, 2013 in which to file appellee's brief.

6. Counsel for appellee has attempted to reach counsel for appellant regarding concurrence in this motion, but has been unsuccessful.

WHEREFORE, appellee respectfully submits that the Court should grant this request and permit the filing of its brief on or before September 18, 2013.
