PETITION TO SET ASIDE NOMINATION PETITION

Donna Heath-Gonzalez and Taheem Gonzalez, Petitioner-Objectors, by and through undersigned counsel, respectfully aver that:

Jurisdiction

1. This Court has original jurisdiction in cases relating to election challenges for candidate for State Representative. *See* 42 Pa. C.S. § 764(1); 25 P.S. § 2937.

Background

2. Donna Heath-Gonzalez and Taheem Gonzalez are both registered Democratic electors who reside in the 189th Legislative District at 2369 Snapdragon Point in East Stroudsburg, Pennsylvania.

3. On or about March 25, 2022, Andre R. Reames, Sr. (“Candidate”) filed a 10-page nomination petition seeking the Democratic nomination for State Representative from the 189th Legislative District.
4. On or before March 28, 2002, Candidate filed 3 supplemental pages of that nomination petition.
5. A copy of Candidate’s nominating petition, including both the original and the supplement, (the “Nominating Petition”) is attached hereto as Exhibit A.
6. Including lines that were altered or stricken, the Nominating Petition contains information on 390 lines, thirty (30) on each page, of the 13-page petition.
7. Candidates for State Representative are required to file nominating petitions with 300 valid signature lines. 25 P.S. § 2872.1(14).

The Circulator or Circulators

8. The candidate turned in only 13 pages, all of which he purportedly signed as the circulator, thereby vouching that he personal circulated the page, that he lives at 18 Mill Creek Road, that each of the 390 people that signed the petition had certain requisite knowledge, including their identity.
9. Despite the fact that all 13 pages were allegedly signed by the candidate himself, various circulator statements are signed in slightly different handwriting and use slightly different printing. Furthermore, the various petitions make a series

of mistakes or different choices of how to write the City name, the County, and even repeating mistakes on multiple pages where he purportedly signed on the line for the county name multiple times, which he then corrected in multiple different ways.

10. Upon information and belief, Objectors believe that the circulator statement was completed by multiple different individuals. It is possible that both are named Andre Reames and live at the same address, of course (the candidate is a “Sr.” after all), but only one such Andre Reames is registered to vote at that address.

11. Objectors thus object to every page, and every line, for containing a defective and false circulator’s statement due to the identity of the signer.

Other Fraud by the Circulator(s)

12. But the issue is not only one of identity, but of clear fraud by the Circulator.

13. On each page, the Candidate’s statement as a circulator would be false, and subject to the penalties of 18 Pa. C.S. § 4904, if the circulator personally signed the petition in the name of others. Particularly on a repeated basis.

14. But, except for page 3, every page shows numerous instances of one person signing for others and/or adding information of others.

15. Pages 1, 2, 4, 6, 7, 8, 9, 10, 11, and 12, each contain a block of adjacent lines containing the same writing which contains the distinctive use of a capital S in the shape of the number 8 that can be seen on many of the circulator statements.

16. In short, **the circulator (or circulators) who signed the Candidate's name as circulator created large chunks of signatures at the kitchen table on at least 12 of the 13 pages turned in by Candidate.**

17. While Objectors are separately including line-by-line challenges, *every* line of pages 1, 2, and 4 thru 13 are challenged due to a false circulator statement, leaving only 19 lines unchallenged (11 of the lines on page 3 are separately challenged as discussed below).

Line-by-Line Challenges

18. In addition to the circulator objections discussed in Paragraphs 8 through 17, 336 lines are separately challenged as invalid on other ground, for the reasons set forth on the spreadsheet attached hereto as Exhibit B.

19. Petitioner respectfully reserves the right to add such additional objections as are appropriate under applicable law at the time of the hearing.

20. Because it does not contain the required 300 valid signature lines, the Nomination Petition fails to conform to the requirements of the Election Code, 25 P.S. § 2867 *et seq.*, and must be set aside and the Candidate's name should not be placed upon the ballot.

WHEREFORE, Petitioners pray this Honorable Court order that Andre Reames not appear on the 2022 ballot for nomination in the 189th Legislative District.
