## PETITION TO SET ASIDE NOMINATION PETITION

Kathryn Jeziorski, Petitioner-Objector, by and through undersigned counsel, respectfully avers that:

#### Jurisdiction

1. This Court has original jurisdiction in cases relating to election challenges for candidate for State Representative. *See* 42 Pa. C.S. § 764(1); 25 P.S. § 2937.

# Background

- 2. Kathryn Jeziorski is a registered Republican residing in the 82<sup>nd</sup> Legislative District at 267 Wiltree Court, State College, Pennsylvania.
- 3. On or about March 21, 2022, Justin Behrens filed a petition seeking the Republican nomination for State Representative from the 82<sup>nd</sup> Legislative District.

- 4. In connection with the filing of the nomination petition, Mr. Behrens filed an affidavit purporting to state that he is eligible for the office of State Representative from the 82<sup>nd</sup> Legislative District. A copy of the affidavit is attached as <u>Exhibit A</u>.
  - 5. The 82<sup>nd</sup> District is located entirely in Centre County.
- 6. Mr. Behrens is currently registered to vote in Centre County at 558 Clarence Avenue in State College.
- 7. Objectors are uncertain if Mr. Behrens has, in fact, ever lived in Centre County or if he simply has a Centre County mailing and voter registration address.
- 8. Prior to moving to Centre County, if he truly has made such a move, Mr. Behrens was registered in Luzerne County, where he was, amongst other positions, chair of the Luzerne Republican Party.
- 9. Mr. Behrens resigned as the Chair of the Luzerne Republican Party on December 3, 2021.
- 10.Upon information and belief, Mr. Behrens continues to be employed in Luzerne County.
- 11.Upon information and belief, Mr. Behrens's family continues to reside in Luzerne County.

# Behrens is Constitutionally Ineligible for this Office

12. The Pennsylvania Constitution sets the requirements for the qualification of members of the General Assembly in Article II, Section 5.

## 13. Section 5 reads, in full:

Senators shall be at least 25 years of age and Representatives 21 years of age. They shall have been citizens and inhabitants of the State four years, and **inhabitants of their respective districts one year next** before their election (unless absent on the public business of the United States or of this State), and shall reside in their respective districts during their term of service.

Pa. Const. art. 2, § 5. (emphasis added).

14. The 2022 general election will be held on November 8, 2022, so, thus, candidates for State Representative in the 2022 election are required to have lived in the district, as currently constituted after the decennial redistricting process, continually since November 8, 2021.

15.Mr. Behrens has not lived in what are the current boundaries of the 82<sup>nd</sup> District continually since November 8, 2021.

#### Behrens Files a False Affidavit

16. Candidates for office in Pennsylvania are required to complete an "affidavit" that contains certain information, including residence, election district, the office sought, that the person is eligible for such office, and a number of other elements. See 25 P.S. § 2870.

17. The statute expressly and explicitly requires an affidavit and expressly requires, *inter alia*, that the candidate swear or affirm that he or she is eligible for such office. *Id*.

- 18.Mr. Behrens executed the Department of State's form affidavit on March 21, 2022, with information he provided to create the affidavit. *See* Exhibit A. However, on March 21, Mr. Behrens knew the affidavit was false because Mr. Behrens was not a resident of the 82<sup>nd</sup> District, and not even a resident of Centre County by November 8, 2021.
- 19.Mr. Behrens was not ill-informed. He previously twice ran for State
  Representative from Luzerne County. Mr. Behrens was a very successful chair of
  the Luzerne County Republican Party and recruited numerous candidates for
  numerous offices during his tenure.
- 20.Mr. Behrens is, and on March 21 was, intimately aware with the qualifications for office, including the residency requirement.
- 21.Mr. Behrens is, and on March 21 was, intimately aware of the fact that his relocation to Centre County came after November 8, 2021, and that he was thus ineligible for the office he desired to seek.
  - 22. In short, Mr. Behrens knew his purported affidavit was a lie.
- 23.Mr. Behrens knew that if he told the truth that his petition would be rejected by the Secretary of the Commonwealth and chose to deceive and ascribe the lie.
- 24.A knowingly false affidavit is not an affidavit at all. *See In re Nom. Pet. of Cianfrani*, 467 Pa. 491, 359 A.2d 383, 384 (1976).

25. Would-be candidates who knowingly file false affidavits must be removed from the ballot. See 25 P.S. § 2937; Cianfrani, 359 A.2d at 384; In re Nom. Pet. of Driscoll, 847 A.2d 44 (Pa. 2004); In re Nom. Certificate of Ramirez (Pa. Cmwlth. No. 44 M.D. 2017, filed February 23, 2017) (as cited in Pa Democratic Party v. Pa. Dept. of State, 159 A.3d 72 (Pa. Commw. 2017).

WHEREFORE, Petitioners pray this Honorable Court to set aside the Nomination Petition and order that Justin Behrens not appear on the 2022 ballot for nomination in the 82<sup>nd</sup> Legislative District.
