#### 1. IT IS HEREBY ORDERED :

A. Hearing on the Objection Petition is scheduled for

, in Courtroom Number , of the

Pennsylvania Judicial Center, 601 Commonwealth Avenue, Harrisburg, Pennsylvania 17120.

Objector is directed to secure the services of a court stenographer for the hearing. Failure of Objector to secure the services of a court stenographer may result in the dismissal of this matter.

B. If signature lines are challenged, Objector shall secure, by request or subpoena, the presence of a Statewide Uniform Registry of Electors (SURE) system operator at the hearing.

C. Service of the Objection Petition on Candidate and this Order on all parties is complete upon posting of the Objection Petition and this Order on the Court's website in accordance with this Court's Notice and Order in In re: Objections to Nomination Petitions/Papers of Candidates for Statewide and State-Level Office (Pa. Cmwlth., No. 126 Misc. Dkt. No. 3, July 19, 2023).

D. At the hearing, Objector shall offer proof of timely service of the Objection Petition on the Secretary of the Commonwealth.

## 2. It is FURTHER ORDERED that the parties shall comply with the following in advance of the hearing:

A. Objector shall file a list of all witnesses to be called at the hearing and the curriculum vitae and expert report for each expert witness. Any witnesses not identified may be precluded from testifying except for good cause shown.

B. Candidate shall file a list of all witnesses to be called at the hearing and the curriculum vitae and expert report for each expert witness. Any witnesses not identified may be precluded from testifying except for good cause shown.

## 3. If signature line challenges are at issue, it is FURTHER ORDERED that the parties shall comply with the following in advance of the hearing:

A. Objector and Candidate or Candidate's representative and, if appropriate, a SURE system operator, shall meet to review each and every challenged signature line.

- B. Objector and Candidate shall file a stipulation of the parties the identifies:
  - (a) the total number of completed signature lines submitted;
  - (b) the total number of uncontested signature lines submitted;
  - (c) the total number of signature lines challenged;
  - (d) each and every signature to which there is an objection, identified by page and line number, and the basis for the objection;
  - (e) each and every signature line to be stricken as invalid or for which an objection is to be withdrawn, identified by page and line number, if the parties can reach such a stipulation.

C. Candidate shall File a list of all signature lines, identified by page number and line number, that is facially defective and that Candidate intends to rehabilitate. Candidate shall also state the manner in which Candidate intends to rehabilitate the signature lines.

4. Objector and Candidate may each file a memorandum of law in support of their respective positions. No further memoranda will be permitted unless ordered by the Court.

5. Unless otherwise ordered, the parties shall file all items required or permitted by paragraphs 2. 3 and 4 of this Order no later than 48 hours in advance of the hearing. Filing may be accomplished by PACFile (the Pennsylvania appellate court electronic filing system) or by email to <u>CommCourtFiling@pacourts.us</u>. Parties may <u>not</u> file by facsimile without express prior permission from the Court.

6. Failure to comply with any provision of this Order may preclude the noncompliant party from entering any evidence, and may result in the imposition of monetary sanctions.

#### PETITION STATING OBJECTIONS TO NOMINATION PETITION OF ERIC BEEZER AS A REPUBLICAN CANDIDATE FOR THE OFFICE OF REPRESENTATIVE OF THE 96<sup>TH</sup> DISTRICT <u>OF THE PENNSYLVANIA GENERAL ASSEMBLY</u>

#### TO THE HONORABLE, THE JUDGES OF THE SAID COURT:

Petitioner, ALAN P. HAWKINS, by his attorney, Gregory Paulson, respectfully represents the following:

- 1. Petitioner, ALAN P. HAWKINS, is an adult individual residing at 1025 Grandview Boulevard, Lancaster (Manheim Township), County of Lancaster, and Commonwealth of Pennsylvania 17601. Petitioner is an elector in Legislative District 96 of Pennsylvania, and is a registered to vote as a member of the Republican Party of Pennsylvania.
- 2. Petitioner seeks relief on his own behalf as an individual elector and on behalf of all Republican voters in the 96<sup>th</sup> Legislative District of Pennsylvania.
- Respondent, ERIC BEEZER, is an adult individual who allegedly resides at 110 East Oregon Road, Manheim Township, County of Lancaster, Commonwealth of Pennsylvania, within the 96<sup>th</sup> Legislative District of Pennsylvania.
- 4. On February 13, 2024, Respondent filed a nominating petition with the Pennsylvania Department of State, seeking nomination as a candidate of the Republican Party for the office of Representative for the 96<sup>th</sup> Legislative District of the Pennsylvania General Assembly.
  - A true and correct copy of Respondent's "Petition To have Name of Candidate Printed upon the Official Ballot for the Primary Election" is attached hereto as <u>Exhibit A</u> and incorporated herein by reference (hereinafter "Petition"). Said <u>Exhibit A</u> is comprised of 19 separate "pages," with each page having a "Side 1" and a "Side 2".
  - b. Each page of <u>Exhibit A</u> allegedly bears the signatures of registered and enrolled members of the Republican Party (hereinafter: "Republican voters") residing in the 96<sup>th</sup> District.

- c. The total number of signatures of "Republican voters" submitted in support of Respondent's nomination was from, allegedly, 323 individuals.
- 5. General Assembly candidates must obtain at least three hundred (300) signatures of registered electors of the political party for which his/her candidacy is sought on any petition for eligibility on the Primary Election ballot. 25 P.S. § 2872.1(14).

- 6. The nomination Petition filed by and on behalf of Respondent ERIC BEEZER is defective because it fails to have 300 valid signatures of registered Republicans voters who reside in the 96<sup>th</sup> Legislative District of the General Assembly.
- Attached as <u>EXHIBIT B</u> to this Petition objecting to the Nomination Petitions of Respondent ERIC BEEZER is a comprehensive spreadsheet of the detailed objections regarding the signatures submitted by Respondent ERIC BEEZER. Said <u>EXHIBIT B</u> is incorporated herein by reference.
- 8. The nomination Petition filed by and on behalf of Respondent ERIC BEEZER is defective because it fails to have 300 valid signatures of registered Republicans in the 96<sup>th</sup> Legislative District of the General Assembly as more fully explained below:
  - A. **Duplicate Signatures**: <u>EXHIBIT A</u> contains duplicate signatures from 2 voters. See <u>EXHIBIT B</u>, "DUP" column.
    - 1. Page 11, Line 12 and Page 8, Line 4 contains the duplicate signatures of Sharon Valldes; and
    - Page 18, Line 9 and Page 2, Line 5 contains the duplicate signatures for registered voter Elizabeth D. Johnson. She signed as "Elizabeth Duffy Johnson" - as "Elector" - on Page 2 on 2/7/24, and then as "E. Duffy Johnson" on Page 18 as "Elector" on 2/10/24 and as "Circulator" on 2/13/24.
    - 3. Two (2) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
  - B. Not Registered in the District: <u>EXHIBIT A</u> contains signatures from 2 voters who are not registered in the 96<sup>th</sup> District. See <u>EXHIBIT B</u>, "NRD" column.
    - 1. Page 11, Line 17 contains the signature of Mark Stancavage who resides at 1808 N. Eden Rd, which is in the 97th Legislative District.
    - 2. Page 18, Line 3 contains the signatures of Zach Weaver who resides at 101 Hibiscus Court, which is in the 97th Legislative District.
    - 3. Two (2) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
  - C. Not Registered in Candidate's Party: The Pennsylvania Election Code requires that persons signing Petitions be "registered and enrolled members of the of the designated party of the potential candidate, in this case, the Republican Party. Upon information and belief, the following persons *are not members of the Republican Party*: <u>EXHIBIT A</u> contains signatures from 7 voters who are not registered in the Republican Party. See <u>EXHIBIT B</u>, "NRCP" column.

- 1. Page 1, Line 10 contains the signature of Neftali Cardona who is registered as "Other."
- 2. Page 1, Line 17 contains the signature of Todd Devenburgh who is registered as "Independent."
- 3. Page 2, Line 1 contains the signature of Daniel Martin who is registered as "Democratic."
- 4. Page 2, Line 17 contains the signature of Ana Merced who is registered as "No Affiliation."
- 5. Page 5, Line 8 contains the signature of Sean Bennington who is registered as "No Affiliation."
- 6. Page 7, Line 1 contains the signature of Naisha Torres who is registered as "No Affiliation."
- 7. Page 16, Line 17 contains the signature of Deanna Brivchik who is registered as "Reform" and under the name D. Brivhik-Sivits.
- 8. Seven (7) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions because they are not members of the Republican Party.
- D. Not Registered at the Address provided: <u>EXHIBIT A</u> contains signatures from 15 voters who are not registered at the address each petition signer provided. See <u>EXHIBIT B</u>, "NRA" column.
  - 1. Page 1, Line 11 Mark Williams is not registered at the address he provided.
  - 2. Page 2, Line 4 Mark D. Fetterman is not registered at the address he provided.
  - 3. Page 3, Line 10 Joseph Frey is not registered at the address he provided.
  - 4. Page 4, Line 8 Lisa Bliznyuk is not registered at the address she provided.
  - 5. Page 7, Line 9 Linda Brike (sp?) is not registered at the address she provided.
  - 6. Page 7, Line 14 Kathy Pearson (sp?) is not registered at the address she provided.
  - 7. Page 10, Line 2 Robert Sundy (sp?) is not registered at the address he provided.
  - 8. Page 12, Line 1 Sandra Ladd is not registered at the address she provided.
  - 9. Page 12, Line 3- Tanya Dryers (sp?) is not registered at the address she provided.
  - 10. Page 16, Line 20 Rick Kuhns is not registered at the address he provided.
  - 11. Page 17, Line 5 Keith Emrich is not registered at the address he provided.
  - 12. Page 17, Line 7 Illegible writing does not match a name registered at the address she provided.
  - 13. Page 17, Line 29 E. Kathleen Alwine (sp?) is not registered at the address she provided.
  - 14. Page 18, Line 4 Christi Johnson is not registered at the address she provided.
  - 15. Page 19, Line 2 Jeffrey Cameron is not registered at the address he provided.
  - 16. Fifteen (15) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.

- E. Inactive Voter Registration: REGISTERED VOTERS: The Pennsylvania Election Code requires that persons signing Petitions be "registered and enrolled members of the of the designated party ....." The Respondent's designated party for the purposes of this objection is the Republican Party. Upon information and belief, the following persons *are not active electors*. <u>EXHIBIT A</u> contains signatures from 3 voters whose registration records have apparently expired. See <u>EXHIBIT B</u>, "Other" column, Lines 35-37.
  - 1. Page 3, Line 1 Pearl McCahon is not an active voter.
  - 2. Page 4, Line 22 Norman Monack is not an active voter.
  - 3. Page 5, Line 16 Carol Walton is not an active voter.
  - 4. Three (3) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
- F. Signatures dated out of sequence: The Election Code, 25 P.S. § 2869(f) requires proper dating of each signature on a petition. <u>EXHIBIT A</u> contains signatures from 2 voters whose signature are out of sequence. See <u>EXHIBIT B</u>, "Other" column, Lines 38 and 42.
  - 1. Page 6, Line 6 The date provided is "2/2/24" when all other dates provided 2/12/24.
  - 2. Page 17, Line 12 The date provided is "2/12/24" when 2/13/24 is provided on lines 9-11 and lines 13-30.
  - 3. Two (2) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
- G. **Registered names are different than those provided:** <u>EXHIBIT A</u> contains signatures from 2 voters whose printed names are different from their registered names. See <u>EXHIBIT B</u>, "Other" column, Lines 39 and 40.
  - 1. Page 14, Line 12 The name provided is Jasmine Rakszanski; she is registered as Jasmine Maloney.
  - 2. Page 16, Line 4 The name provided is Khristine Buckius; she is registered as Khristine Bessler.
  - 3. Two (2) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
- H. The provided signatures are incomplete or otherwise deficient. <u>EXHIBIT A</u> contains signatures from 2 voters whose signatures are questionable. <u>EXHIBIT B</u>, "Other" column, Lines 41 and 43.
  - 1. Page 16, Line 7 The signature of Whitney Esbenshade appears to be incomplete.
  - 2. Page 18, Line 20 It is unclear whether this is the signature of Christopher Harris or Christina Harris.
  - 3. Two (2) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.

- I. **Line information has been omitted.** <u>EXHIBIT A</u> contains signatures from 7 voters who failed to provide all the requested information. See <u>EXHIBIT B</u>, "LIO" column.
  - 1. Page 2, Line 6 The information provided impermissibly uses "ditto" marks.
  - 2. Page 7, Line 4 Roberta Bennett failed to provide a "City/Twp/Boro."
  - Page 9, Line 1 Michelle Zhang provided her address as Lititz, which is not in the 96<sup>th</sup> Legislative District.
  - 4. Page 9, Line 2 Megan Tiburtini provided her address as Lititz, which is not in the 96<sup>th</sup> Legislative District.
  - 5. Page 9, Line 3 Frances Guglie provided her address as Lititz, which is not in the 96<sup>th</sup> Legislative District.
  - 6. Page 9, Line 4 Mary Cummons provided her address as Lititz, which is not in the 96<sup>th</sup> Legislative District.
  - Page 9, Line 5 Sara Rasniak provided her address as Lititz, which is not in the 96<sup>th</sup> Legislative District.
  - 8. Seven (7) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
- J. Information provided is illegible. <u>EXHIBIT A</u> contains signatures from 6 voters whose names and other required information is totally illegible. See <u>EXHIBIT B</u>, "ILL" column. They are at:
  - 1. Page 5, Line 14
  - 2. Page 6, Line 11
  - 3. Page 11, Line 14
  - 4. Page 13, Line 10
  - 5. Page 13, Line 21
  - 6. Page 16, Line 22
  - 7. Six (6) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
- K. Signatures impermissibly provided only initials or nicknames instead of the actual, registered names of the persons signing. <u>EXHIBIT A</u> contains signatures from 4 voters whose registered names are different than those provided. See <u>EXHIBIT B</u>, "N/I" column.
  - 1. Page 5, Line 2 Martin J. Puchalski signed as "MJ Puchalski."
  - 2. Page 5, Line 11 Gualberto Perez signed as "G Perez."
  - 3. Page 11, Line 18 Gasper Romano signed as "Gabby Romano."
  - 4. Page 18, Line 16 Cornelia West signed as "Connie West."
  - 5. Four (4) signatures are thus invalid and must be stricken from Respondent's Nomination Petitions.
- L. A signature appears to have been printed rather than provided in long-hand form. <u>EXHIBIT A</u> contains information from 1 voter but not a signature as required. See <u>EXHIBIT B</u>, "PRI" column.
  - 1. Page 13, Line 8 Michael Juba appears to have printed his name twice, ignoring the requirement of providing an actual signature.

- 2. This one (1) signature is thus invalid and must be stricken from Respondent's Nomination Petitions.
- 9. SUMMATION:
  - A. The total number of signatures submitted by Respondent supporting his nomination is 323.
  - B. The total number of signatures objected to by Petitioner, Alan P. Hawkins, is 53.
  - C. The total number of apparently valid signatures on Eric Beezer's Nomination Petitions thus equals only 270 qualified electors who are actually registered and enrolled in the Republican Party, and who meet the requirements of the Pennsylvania Election Code, 25 P.S. § 2872.1(14).
- 10. Since there are fewer than one hundred (300) valid signatures of Republican Electors on Respondent's Petition indeed, there are 270 or fewer his Petition is deficient and the entire Petition of Eric Beezer must be stricken.

#### **REMEDY SOUGHT**

- 11. Petitioner requests your Honorable Court to find that the nomination Petition for the alleged Republican candidate, ERIC BEEZER as the Republican Candidate for the Office of Representative of the 96<sup>th</sup> Legislative District of the Pennsylvania General Assembly contains material and fatal defects which require that fifty-three (53) signatures of the signatories on Exhibit A, be stricken from said nomination Petition.
- 12. Petitioner further requests your Honorable Court to find that the nomination Petition for the alleged Republican candidate, ERIC BEEZER, contains material and fatal defects, namely that it contains fewer than the required number of three hundred (300) valid signatures required by the Election Code, 25 P.S. § 2872.1(14).
- 13. Petitioner requests your Honorable Court to find that, having failed to meet the statutory requirements with regard to the number of valid signatures, Respondent's entire nomination Petition be stricken.
- 14. Pursuant to the Pennsylvania Election Code, 25 P.S. § 3502.1, Petitioner is entitled to recover court costs, including filing fees, service fees, attorney fees and other costs and expense in the event the Court finds respondent made false statements regarding his eligibility for public office.

WHEREFORE, Petitioner, ALAN P. HAWKINS, requests this Honorable Court to:

- (A) Schedule a hearing as provided for in Section 977 of the Election Code, 25 P.S. § 2937;
- (B) Enjoin the Pennsylvania Department of State Elections Bureau from certifying ERIC BEEZER, as an eligible candidate for Representative of the 96<sup>th</sup> Legislative District of the Pennsylvania General Assembly, on the Republican ballot for the April 23, 2024

Primary Election, or, in the alternative, issue an Order finding the petition of ERIC BEEZER, defective and setting aside or striking said petition; and

(C) Award Petitioner court costs, expenses, and attorney fees in accordance with the Pennsylvania Election Code, 25 P.S. § 3502.1.
