

#### Honorable Judge Flaherty:

I thank you for taking the time to read this correspondence which I feel is of great importance. Firstly, I am a former Philadelphia Police Officer who served for twenty-five years in that capacity. I served nearly five years as a Claims Investigation Agent Supervisor for the Philadelphia Region of Pennsylvania's Office of Inspector General. I am an author of an autobiography of the challenges I faced after reporting serious incidents of criminal and unethical behavior of Police Officers and Commanders with whom I worked. Presently, I serve on City Council of the City of Snellville, Georgia. I have been a "Facebook Friend" of Honorable Judge Mark B. Cohen since January 23, 2023. Please note that it is only recently that I was made aware the he is a Judge of the Philadelphia Court of Common Pleas.

If you research my law enforcement career in Philadelphia, you will find that I had an extensive history of writing "Letters to the Editor" to the three major Philadelphia newspapers in existence at the time. One of my letters led to an appearance on Dateline NBC concerning the type of unethical police behavior that impeded the apprehension of the rape and murder of Shannon Scheiber in center city. It is important to understand that throughout my public writings I had to be keenly aware of keeping within ethical and non-political guidelines.

As an elected official serving in a non-partisan position, I am still bound by ethical and non-political guidelines. Throughout the nearly nineteen months that Judge Cohen and I have shared opinions via social media, we have opined about bettering the human condition without stepping into the sphere of political partisanship. For me, and I am sure with Judge Cohen, this is essential. Both of us care about our neighbors, our country, and our world. Such a concern is outside of the realm of politics. All of us, regardless of public service, must have the freedom to communicate publicly that being "our brother's keeper" is a moral imperative and not a partisan political platform. Dear Judge Flaherty,

I have known Judge Cohen for about 35 years, since his time as a State Representative. We have been Facebook friends since 2012. I got to know him when I was president of Temple University's faculty union, the Temple Association of University Professionals. I would go to Harrisburg on a yearly basis to ask for greater funding for Temple, sometimes accompanying Temple's senior administrators. Occasionally during these visits, I would meet with Representative Cohen to ask for his help. Sometimes, I would also ask for his support on labor-related legislation or express support for some bills he sponsored. I retired from my union position and from Temple's faculty in December 2017 and am now an emeritus professor.

Over the past 12 years, I have enjoyed Judge Cohen's daily posts on Facebook. I check my Facebook feed several times per day, so I've seen virtually all his messages. Once he became a judge in 2018, I noticed that he stopped making partisan comments and made more neutral or strictly informative ones. Since that time, I have not seen any political, partisan, or biased posts. I believe that the claims that his Facebook messages are "Democratic" or "left wing" are not credible.

Thank you for the opportunity to express my perspective. I hope that you will take my views under consideration in your ultimate decision.

Dear Honorable Judge Flaherty,

I am writing to express my concerns regarding the judicial discipline proceeding against Philadelphia Family Court Judge Mark Cohen. I read the complaint against Judge Cohen, including the Facebook postings that serve as evidence. Judge Cohen and I have been interacting on Facebook for several years and I never felt he was attempting to influence my political opinions. This disciplinary proceeding is an insult to me and an attempt to violate my First Amendment right to assemble online and communicate with Judge Cohen peacefully.

This disciplinary proceeding raises some questions I ask you to please consider.

Is Judge Cohen accused of showing any political bias that influenced any of the decisions he has made in his courtroom? Has Judge Cohen expressed any public views that might give any plaintiff or defendant in any cases he has adjudicated reasonable cause to question his fairness? Exactly how have any of Judge Cohen's Facebook postings shown any bias that would influence citizens on how we should vote?

As a born and raised Pennsylvanian, I find this disciplinary proceeding against Judge Cohen an infringement on my right to free speech. Is there any evidence that Judge Cohen has successfully influenced anyone else's voting decisions? No offense to him, but I don't need Judge Cohen to tell me how to vote. I suspect that you and everyone else who has read his Facebook postings don't either. None of the postings I have seen on Judge Cohen's Facebook page have attempted to influence how I or anyone else votes. All of his postings on current events are simply statements of fact, not endorsements of the Democratic Party or any Democratic candidate.

Although I am not an attorney, it seems to me that Judge Cohen has the same First Amendment right to peacefully assemble and share his thoughts on social media platforms such as Facebook as anyone else. Judge Cohen has never posted anything about any case he has heard on his Facebook page. Limiting discourse about current events with Judge Cohen in a public forum, such as Facebook infringes on the rights of everyone who engages in conversation with him.

Judge Cohen and I have never met in person, but his sister Sherrie and I know each other. When I supported Sherrie in her bid for an at-large seat on the Philadelphia City Council, I attended a small event for her at the Country Club Diner. I asked Sherrie why her brother wasn't there. Sherrie explained that judges can't support political candidates. That's despite Sherrie running for office as an independent candidate, not as a Democrat. You will not see any evidence in Judge Cohen's Facebook postings that he supported his sister's campaign. That's clear evidence of his integrity and his commitment to being non-partisan. Judge Cohen's decision to be uninvolved with his sister's political ambitions and that none of his Facebook postings recommend anyone support Democratic candidates are reasons enough to dismiss this disciplinary proceeding against him.

If Judge Cohen ever gives us voters a reason to doubt his fitness as a judge, we can exercise our right to remove him from the bench when he comes up on our ballot for judicial retention. I, therefore, respectfully ask you to please dismiss this disciplinary proceeding against him.




Whichever major candidate you wish to win the Presidential race, you can find polls showing that he or she is ahead. But whatever any polls say, you should VOTE.


