And now comes the Pritioner, the Northampton County Republican Committee, by and through its Solicitor and counsel, Kevin Frank Danyi, Esq., and says and avers the following:

- 1. This Petition is brought pursuant to 25 P.S. § 3046.
- 2. The Petitioner is the Northampton County Republican Committee (the "NCRC"), a political party and county committee with multiple Republican candidates on the ballot in this General Election.
 - a. The NCRC is a political party as defined in 25 P.S. § 2831.
 - b. The NCRC is a county committee as defined in 25 P.S. § 2837.
 - c. The NCRC has standing to bring this Petition under the Pennsylvania Election Code, 25 P.S. § 2601, et seq.
- 3. The Respondent is the County of Northampton (the "County").
- 4. The County, in the ordinary course of government business and operation and management of elections, compiles and maintains a list of polling places in Northampton County. 25 P.S. § 2726.
- 5. The County also routinely compiles and maintains information and a list (the "List") of each "District Election Board", consisting of the Judges of Election, Majority Inspectors, and Minority Inspectors for each polling place in Northampton County. 25 P.S. § 2671.
 - a. It is believed, and is therefore averred, that the List is a public record.

- b. The County has provided this List to the NCRC in the past, upon request by the NCRC, as recently as the 2023 General Election.
- c. The List is used by the NCRC and political candidates for lawful Election Day purposes, poll watcher stationing, etc.
- 6. On October 1, 2024, Andrew Azan III, the Vice Chairman of the NCRC, sent email correspondence to Chris Comini and Amy Hess at the County Elections Office, requesting the List for the 2024 General Election. The County did not provide the List or even reply to the NCRC.
- 7. On October 17, 2024, Mr. Azan again sent email correspondence to Mr. Comini and Ms. Hess. The County did not provide the List or even reply.
- 8. On October 24, 2024, Mr. Azan again sent email correspondence to Mr. Comini and Ms. Hess. The County did not provide the List or even reply.
- 9. On October 28, 2024, Mr. Azan again sent email correspondence to Mr. Comini and Ms. Hess. The County did not provide the List or even reply.
- 10. Also on October 28, 2024, Kevin Frank Danyi, Esq. ("Attorney Danyi"), the NCRC Solicitor and General Counsel, sent email correspondence to Melissa P. Rudas, Esq. (County Solicitor) and Michael A. Vargo, Esq. (Assistant County Solicitor) requesting a response to Mr. Azan's multiple emails.
- 11. Neither Attorney Rudas nor Attorney Vargo responded to Attorney Danyi.
- 12. A printout of the email correspondence chain is attached hereto, made a part hereof, and called Exhibit "A".
- 13. On October 30, 2024, Mr. Azan, on behalf of the NCRC, personally went to the County Election Office and requested the List from Mr. Comini. Mr. Comini refused to provide the public records to the NCRC, and referred Mr. Azan to Attorney Vargo.
- 14. On November 1, 2024, Attorney Danyi telephoned Attorney Vargo and left a detailed voice message, requesting the public information and requesting that Attorney Vargo contact Attorney Danyi on Attorney Danyi's personal cell phone. Attorney Danyi also sent email

correspondence to Attorney Vargo and Attorney Rudas confirming his voice message.

- 15. Attorney Vargo failed to respond to Attorney Danyi.
- 16. The NCRC believes, and therefore avers, that the List of Judges of Election, Majority Inspectors, and Minority Inspectors is information freely available to the public and, as the County has not even deigned to reply to the NCRC's repeated requests, that the County is deliberately withholding this information from the NCRC.
- 17. The County Executive, Lamont G. McClure, is a Democrat, as are the appointed senior government officials in the County.
- 18. The NCRC believes, and therefore avers, that the County is acting in a manner that is obdurate, dilatory, vexatious, partisan, and with the intent of putting the NCRC and Republican candidates at a disadvantage on Election Day.

Therefore, the Petitioner prays that this Honorable Court enter an Order directing the County to immediately provide to the NCRC the list of Judges of Election, Majority Inspectors, and Minority Inspectors for every polling place in Northampton County and granting such other relief as the Court deems appropriate under the circumstances.
