# EMERGENCY PETITION OF THE LUZERNE COUNTY ELECTION BUREAU AND LUZERNE COUNTY BOARD OF ELECTIONS AND REGISTRATION REQUESTING AN EXTENSION OF TIME FOR POLLING LOCATIONS TO REMAIN OPEN FOR THE NOVEMBER 5, 2024 GENERAL ELECTION

Petitioner, the Luzerne County Election Bureau ("Bureau") and the Luzerne County Board of Elections and Registration ("Board of Elections"), by its undersigned attorneys, the Luzerne County Office of Law, hereby petitions this Honorable Court for permission to extend the deadline for the time certain polls are to be closed. In support of this Petition, the Luzerne County Election Bureau and Luzerne County Board of Elections and Registration avers as follows:

- 1. In the process of administering the election on November 5, 2024, the Bureau and Board of Elections learned that election officers failed to timely open the polling location in Laflin Borough which resulted in delays in the process of voting.
- 2. Said location did not open until approximately 8:30 a.m. causing an inability for some voters to cast a ballot if they arrived at the polling location and had to leave prior to 8:30 a.m.
- 3. It is the purpose of the court of common pleas on any election day to decide such "matters pertaining to the election as may be necessary to carry out the intent of this act." 25 P.S. § 3046.
- 4. It is well-settled that the purpose of election laws is to ensure fair elections, including an equal opportunity for all eligible electors to participate in the election process. *In re General Election* 1985, 109 Pa.Cmwlth. at 608, 531 A.2d at 839 (Court postponed the date of

the General Election for 11 precincts that suffered extensive flooding, loss of electricity, heat, and water during extreme weather conditions) (*citing, In re Mayor, City of Altoona, Blair County,* 413 Pa. 305, 196 A.2d 371 (1964)).

- 5. In prior instances where a request for an extension of time to allow electors to cast votes in an election, the courts have found that allowing an election to be conducted "where members of the electorate could be deprived of their opportunity to participate because of circumstances beyond their control ... would be inconsistent with the purpose of the election laws." *In re General Election*, 839.
- 6. In the immediate instance, some electors in Laflin Borough, Luzerne County, may require additional time to participate in the General Election because of circumstances beyond their control if the time for closing the polls is not extended.
- 7. The Pennsylvania Election Code states that "At all primaries and elections the polls shall be opened at 7 A.M., Eastern Standard Time, and shall remain open continuously until 8 P.M., Eastern Standard Time, at which point they shall be closed." 25 P.S. § 3045.
- 8. The Election Bureau and Board of Elections now petitions this Honorable Court to extend the statutory deadline at which the Laflin Borough polls are required to close from 8:00 p.m. until 9:30 p.m. on November 5, 2024.
- 9. The Luzerne County Democratic Party, through Attorney Neil O'Donnell, joins in the instant Petition and the relief requested herein.
- 10. PA GOP, through Attorney Kathleen A. Gallagher, joins in the instant Petition and the relief requested herein.
- 11. The Election Bureau and Board of Elections seek this extension so that all of the duly qualified electors of Laflin Borough, Luzerne County, are able to participate in this General Election.

WHEREFORE, the Luzerne County Election Bureau and Luzerne County Board of Elections and Registration respectfully requests this Honorable Court to GRANT its Emergency Petition to extend the deadline for the time the polls are to be closed in Laflin Borough for the November 5, 2024 General Election.
