

Behavioral Health Funding Opportunities

Byrne State Crisis Intervention Program

Goal: Federal Byrne State Crisis Intervention Program (SCIP) funding aims to reduce gun violence through the implementation of state crisis intervention court proceedings and related programs and initiatives.

Eligibility: Pennsylvania counties.

Eligible activities:

- Establishing or enhancing CIT Programs
- Regional crisis call centers
- Crisis mobile team response
- Crisis receiving and stabilization facilities for individuals in crisis
- Triage services
- Community-based services and programming

- Integrated case management and wraparound supports for people who have experienced/witnessed gun violence
- Technical assistance and training to increase adoption of evidence-based practices
- Adoption of the Lethality Assessment Program

Eligible activities may change as PCCD is in the process of creating a new SCIP Plan for 2024 Funds Future Funding: FY 2024 Byrne SCIP Local Solicitation – Spring 2025

Intermediate Punishment Treatment Program Initiative

Goal: The goal of the Intermediate Punishment Treatment Program remains to divert individuals from county jail or state prison and provide the necessary treatment for individuals with substance use or mental health disorders, thereby reducing recidivism and increasing public safety.

Eligibility: Pennsylvania counties.

Eligible activities:

- Drug and alcohol assessment and placement services
- Drug and alcohol treatment services and related activities
- Drug and alcohol testing services

- Mental health treatment and supportive services
- Criminal Justice supervision and related services

Future Funding: Intermediate Punishment Treatment Program Initiative - Spring 2025

School Safety & Mental Health Grants

Goal: Noncompetitive funding to meet both physical security and behavioral health needs, including counselors and resources for students.

Eligibility: School districts, charter schools, area career and technical centers, and intermediate units.

Eligible activities:

- Safety, security, and risk assessments
- Conflict resolution or dispute management
- School-based diversion programs
- Training to undertake a district wide assessment of risk factors that increase the likelihood of problem behaviors among students
- Development and implementation of research-based violence prevention programs

- District-wide school safety, violence prevention, emergency preparedness and all-hazards plans
- Security planning and purchase of securityrelated technology
- Specialized staff and student training programs, including training
- Any eligible activity under <u>24 P.S. §13-1306-B(j)</u>

Targeted School Safety Grants

Goal: The goal of Targeted School Safety Grants is to support programs addressing school violence and improving school safety and security.

Eligibility: Nonpublic schools, municipalities, law enforcement agencies, and approved vendors.

Eligible activities:

- Activities that address school mental health, school violence, or enhance school security
- Costs associated with the training and compensation of school security personnel
- Any eligible activity under <u>24 P.S. §13-1306-B(j)</u>
