How it works:

- *The Office of Attorney General partners with District Attorneys, local police departments and Stakeholders to help open the door to people seeking treatment resources.*
- *When people come in for help, this program helps connect people to resources as well as promises no threat of arrest or prosecution for minor drug offenses.*
- *After conducting a brief intake, law enforcement personnel will help connect individuals immediately to treatment resources.*
- *LETI is a law enforcement led policy through the county district attorney's office.*
- *Anyone can be a referral into treatment with a DA led LETI policy.*

How does the Office of Attorney General help?

- *We will help establish connections and partnerships with your drug and alcohol commission.*
- *An Agent from our office will meet with you to write your policy. Training on your policy is provided to help the program get up and running quickly.*
- *We will assist with promoting your LETI policy in your community and on the AG website. This will ensure that those who need it will know that it is there.*

What would your department need to do?

- *Maintain relationships with your drug and alcohol commission once they are established.*
- *Consider people who are suffering for substance use disorder for a LETI referral.*
- *Help track statistics so that the Office of Attorney General can evaluate and improve the program*

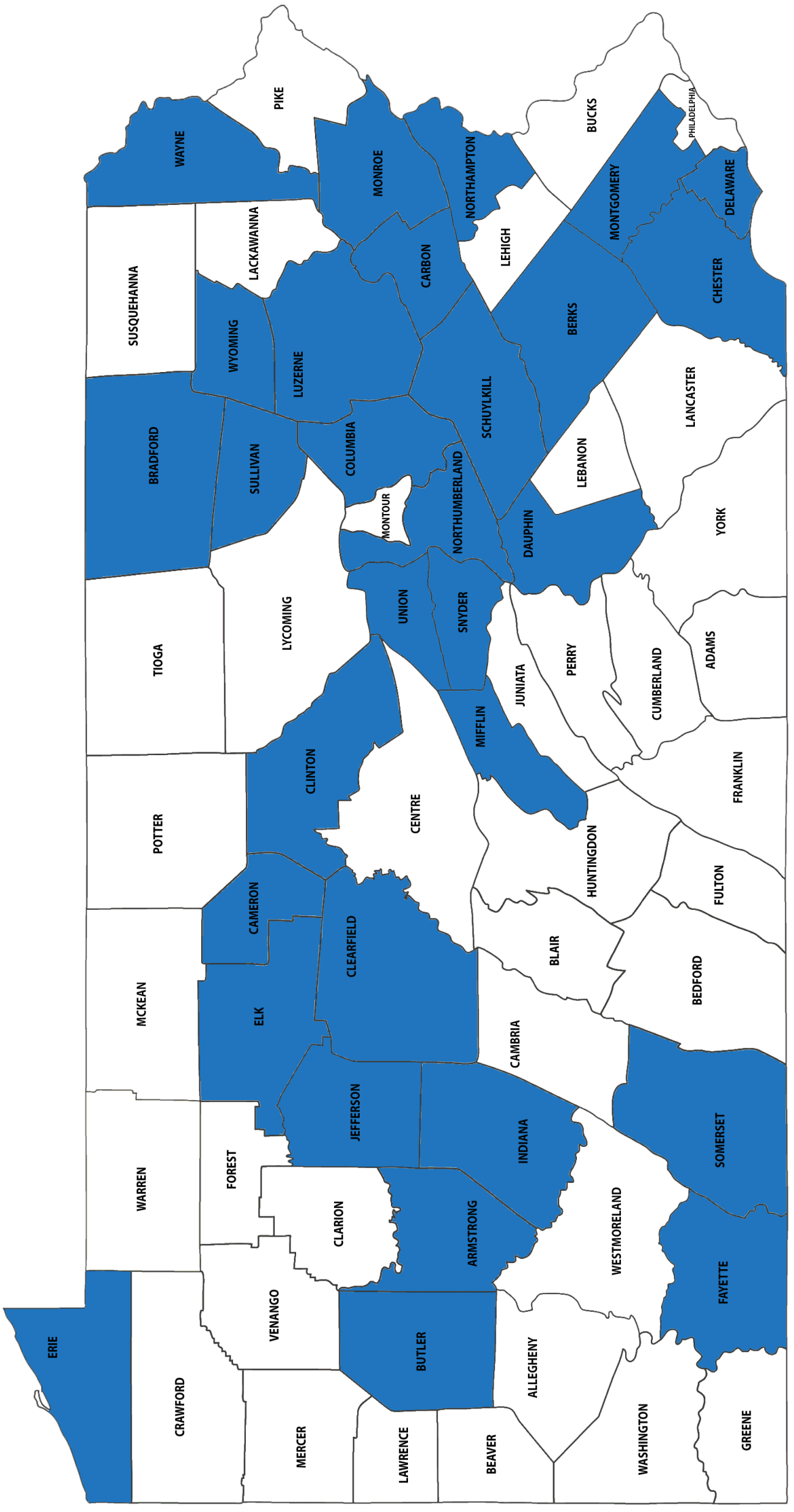
