AND NOW, this 12<sup>TH</sup> day of November 2024, following the Amended Order from 11/05/24 (No. GD-24-011366 – 3) where I ordered the Allegheny County Sheriff's Office to remove signs on 11/05/24 containing misinformation from polling locations (listed below) in the 44<sup>th</sup> Legislative District, it is **ORDERED, ADJUDGED, and DECREED**, that after my staff attempted to reach out to the Driving Education Science & Knowledge PAC to give them an opportunity to retrieve the signs from the Sherriff's Office but we received no response, the Allegheny County Sheriff's Office **shall destroy the signs** retrieved on 11/05/24 (see "Exhibit A" of attached Amended Order).

- (2) The signs falsely portray themselves as public notices from the Pennsylvania Department of State.



- Findlay Township Activity Center, 310 Main Street


