AFFIDAVIT of PROBABLE CAUSE

On January 8, 2023, at approx. 2313Hrs. Officer Brian Johnson discovered an occupied vehicle in the parking lot of the Keystone Conference Center (KCC), 17-104 Essayons Rd. Fort Indiantown Gap, Annville, PA. The KCC was closed for business and the area is posted against trespassing. Off. Johnson contacted the occupants, both of whom were in the rear seat of the vehicle. The occupants were identified as Fahad Pervez and Veronika Rodriguez, both members of the PA Air National Guard. Both occupants did not appear to be in distress, neither requested help and Pervez stated they were there to admire the view.

On January 11, 2023, at approx. 1410Hrs, Veronika Rodriguez came to the Fort Indiantown Gap Police Department to report a sexual assault that occurred at the Keystone Conference Center (KCC), 17-104 Essayons Rd. Fort Indiantown Gap, Annville, PA on January 8, 2023, involving Fahad Pervez.

During the interview of Rodriguez, she reported that Pervez forced her to engage in nonconsensual sexual intercourse while in his vehicle in the parking lot of the KCC and that during this encounter he kept her eyeglasses from her to prevent her from seeing anything clearly. Rodriguez stated that she was contacted by her First Sergeant to provide a statement of the encounter because her name appeared in a police report for the installation. It was during this statement that Rodriguez reported the sexual assault to her First Sergeant. Rodriguez also stated she had a recording of parts of the assault.

On January 13th, 2023, at approx. 1415Hrs, Officer Czerviski and Sgt. Kramer asked Rodriguez if she would consent to have a forensic download of her cellular phone to extract information and evidence related to this reported sexual assault. Rodriguez provided written consent to the extraction and the extraction was conducted by Detective Henry of the Palmyra Police Department on January 13th, 2023.

On January 23rd, 2023, at approx. 1830Hrs, Officer Czerviski and Sgt. Kramer received the data extracted from Rodriguez's phone. Upon investigating the data, we discovered a lengthy audio recording of conversations and sexual acts between Rodriguez and Pervez. These recordings started at approx. 1930Hrs. and continue until approx. 2330Hrs. We located text message conversations between Rodriguez and Pervez discussing setting up another date in the future, Pervez asking if she made it home safe, possibly going to her house to spend time together, and Rodriguez sending Pervez photos of her breasts. We also located a text message conversation between Rodriguez and an individual identified as "Bad Bitch" where Rodriguez discusses the sexual encounter between her and Pervez and describes her level of arousal, that she could "ignore her morals for one night", that she was "horny", kept "grinding" on him for him to get the hint, and Rodriguez rates the sexual encounter as a three in her overall encounters. Rodriguez commented to "Bad Bitch" that her and Pervez could have birthday sex on her next military drill weekend.

Subsequently, we located a different text message conversation between Rodriguez and a contact labeled "Dumb Bitch" where she explains the night in detail and sends this contact video recordings on January 13th, 2023, at 1059 hours of Pervez while the two of them were inside his vehicle on the evening of January 8th, 2023.

On February 15th, 2023, at approx. 1100Hrs, Officer Czerviski and Sgt. Kramer interviewed Fahad Pervez in the presence of his attorney. Throughout this interview Pervez explained their night together and stated that the sexual intercourse was consensual.

The defendant did report knowingly false information to police with the intent to implicate PERVEZ in a criminal investigation and the defendant knowingly recorded PERVEZ in violation of the WIRETAP Act.

I, Patrolman Randy Czerviski, BEING DULY SWORN ACCORDING TO THE LAW, SAY THAT THE FACTS SET FORTH IN THE FOREGOING AFFIDAVIT ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE, INFORMATION AND BELIEF.
