**ORDER ISSUING SUMMONS FOR MAGGIE SANDERS  
TO TESTIFY IN OUT-OF-STATE CRIMINAL CASE**

1. Maggie Sanders is a material and necessary witness in a criminal proceeding pending before the District Court for the Fourth Judicial District of the State of Idaho.

2. Compelling the attendance and testimony of Maggie Sanders will not cause undue hardship to her.

3. The laws of the State of Idaho, where the prosecution is pending, and of any other state through which Maggie Sanders may be required to pass by ordinary course of travel, provide protection to her from arrest and from the service of civil or criminal process while traveling to, attending, and returning from the proceeding.

For these reasons, it is hereby **ORDERED** as follows:

A Summons shall issue, with a copy of the certificate issued by the Honorable Steven Hippler, of the District Court for the Fourth Judicial District of the State of Idaho, pursuant to 42 Pa.C.S. § 5963 attached, directing Maggie Sanders to attend and testify in the criminal proceeding pending in the State of Idaho on the dates of

**PETITION FOR SUMMONS  
DIRECTING WITNESS, MAGGIE SANDERS,  
TO ATTEND AND TESTIFY IN OUT-OF-STATE CRIMINAL PROCEEDING**

Pursuant to 42 Pa.C.S. § 5963, Petitioner respectfully requests that this Court scheduling a hearing and, subsequently, issue a Summons compelling Maggie Sanders to testify in an out-of-state criminal proceeding, and in support of this request avers as follows:

1. Petitioner, the undersigned, has been retained as local counsel by the firm of Ann Taylor Law, in its capacity as counsel for Bryan C. Kohberger, in a criminal proceeding pending in the District Court of the Fourth Judicial District of the State of Idaho, County of Ada, captioned *State of Idaho v. Bryan C. Kohberger*, and bearing docket number: CR01-24-31665.

2. The trial is scheduled to take place from August 11, 2025, until November 7, 2025.

3. Judge Steven Hippler, of the District Court for the Fourth Judicial District of the State of Idaho, has issued a subpoena commanding the appearance and testimony at trial of Maggie Sanders, who lives, works, or does business in Monroe County, Pennsylvania. See copy of the subpoena attached as **Exhibit A**.

4. Pursuant to 42 Pa.C.S. § 5963, Judge Hippler has issued a certificate under seal affirming that:

- a. a criminal proceeding is pending in the District Court for the Fourth Judicial District of the State of Idaho;
- b. Maggie Sanders is a material witness in that proceeding;
- c. the presence of Maggie Sanders is required as a witness in this proceeding for a specified number of days; and
- d. Maggie Sanders will be protected from arrest and service of civil or criminal process while traveling to, attending, and returning from the proceeding.

See a copy of Judge Hippler's 42 Pa.C.S. § 5963 certificate attached as **Exhibit B**.

5. ~~Judge Hippler's certificate constitutes "prima facie evidence of all the facts stated therein."~~ 42 Pa.C.S. § 5963(b).

6. Pursuant to 42 Pa.C.S. § 5963, Petitioner respectfully requests that this Court issue an Order directing Maggie Sanders to appear for a hearing to determine whether she should be compelled to attend and testify in the out-of-state proceeding discussed herein.

**WHEREFORE**, Petitioner respectfully requests that this Court set a date and time for a hearing on this Petition, and following the hearing, issue a Summons directing Maggie Sanders to attend and testify at the criminal trial in Idaho.

Under the laws of the State of Idaho (Idaho Code §19-3005(3)), if Maggie Sanders comes into this State in obedience of a Summons requiring her presence at this Trial, she will not be subject to arrest or service of any process relating to matters that arose before she entered the State under the Summons.



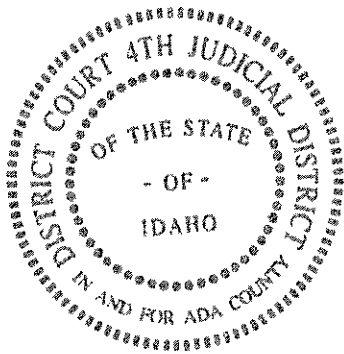
