ORDER OF COURT


AND NOW, this 8th day of September, 2025, a PETITION FOR WRIT OF HABEAS CORPUS AD PROSEQUENDUM having been presented to this Court, upon motion of the Blair County District Attorney without objection by the Defendant (see Exhibit A), entry of the following Order is deemed appropriate.

It is hereby **ORDERED, DIRECTED, and DECREED** that a WRIT OF HABEAS CORPUS AD PROSEQUENDUM issue, requesting that the United States Marshal's Service release the prisoner, Defendant Luigi N. Mangione, (MDC Brooklyn Inmate Registration Number 52503-511) to the custody of the Blair County Sheriff's Department and/or other Blair County law enforcement who shall assume full responsibility for the prisoner's custody and provide for the safekeeping, secure custody, and care of the prisoner at no cost to the federal government in order to physically **PRODUCE** the body

of the prisoner before the Blair County Court of Common Pleas for in-person litigation on the Defendant's omnibus pre-trial motion scheduled for hearing on November 7, 2025 at 1:30 p.m. in Courtroom 1 of the Blair County Courthouse, Hollidaysburg, Pennsylvania. It is **ORDERED** that the prisoner shall be returned promptly to the custody of the United States Marshal's Service upon conclusion of the appearance for which the writ was issued or upon demand of the United States Marshal's Service. This Court understands that the United States Marshals Service reserves the right to deny any request.

Furthermore, the Blair County District Attorney is **ORDERED** and **DIRECTED** to serve the US Marshal and the United States Attorney with a certified copy of this order and to perfect service of the Writ upon the United States Attorney for the Southern District of New York .
