NOTICE OF APPEAL

Notice is hereby given that <u>Robert Williams</u>, defendant above named, appeals to the Superior Court of Pennsylvania from the order revoking probation and imposing a new sentence, entered in this matter on the <u>6th</u> day of <u>November</u>, <u>2017</u>. A timely motion to modify that sentence was filed November 15, 2017, and a related motion to recuse on November 14, 2017. This appeal is also taken from, and encompasses, the court's failure to grant or otherwise act upon those motions.

This court's final order has been entered on the docket as evidenced by the attached copy of the docket entries.

Pursuant to Pa.R.A.P. 1762, the defendant certifies that he is not presently released on bail pending appeal. An application for bail was filed in this court on November 16, 2017, and denied on December 1, 2017. A petition for habeas corpus, seeking to expedite bail release, was filed in the Superior Court on November 17, 2017, and was docketed at No. 133 EDM 2017.
