JOINT PETITION TO TEMPORARILY SUSPEND AN ATTORNEY
PURSUANT TO PA.R.D.E. 214(d)(5)

TO THE HONORABLE, THE CHIEF JUSTICE AND JUSTICES OF THE
SUPREME COURT OF PENNSYLVANIA:

1. Petitioner, Office of Disciplinary Counsel (ODC) whose principal office is located at Pennsylvania Judicial Center, Suite 2700, 601 Commonwealth Avenue, P.O. Box 62485, Harrisburg, PA 17106-2485, is invested, pursuant to Rule 207 of the Pennsylvania Rules of Disciplinary Enforcement (hereafter "Pa.R.D.E."), with the power and the duty to investigate all matters involving alleged misconduct of an attorney admitted to practice law in the Commonwealth of Pennsylvania and to prosecute all disciplinary proceedings brought in accordance with the various provisions of the aforesaid Rules.

2. Respondent, Paul Luvara, was born on November 6, 1990, and was admitted to practice law in the Commonwealth of Pennsylvania on November 24, 2021. He was assigned Attorney Registration No. 331040. He is on "active status". Respondent's attorney registration address is 1114 Allenclair Circle, Pittsburgh, Allegheny County, Pennsylvania, 15241.

3. On November 6, 2024, Respondent, with counsel, entered a plea of guilty in the Court of Common Pleas of Jefferson County at CP-33-CR-0000039-2024 to one Count of Criminal Attempt 18 Pa.CSA §901(a) [Inchoate: Corruption of Minors 18 Pa.CSA §6301(a)(1)(ii)] a felony of the third degree; and One count of Criminal Use of a Communication Facility in violation of 18 Pa.CSA §7512(a) a felony of the third degree. (ODC- Exhibit 4)

4. The Court deferred sentencing pending completion and receipt of a pre-sentence report and a determination of Respondent's status as either a "sexual offender" or "sexually violent predator" 42 Pa.CSA § 9799.12 and to what level, if any, Respondent was required to report pursuant to SORNA registration. (ODC- Exhibit 1)

5. On May 8, 2025, Respondent was sentenced as follows:

(a) On the charge of Criminal Attempt 18 Pa.CSA §901(a) [Inchoate: Corruption of Minors 18 Pa.CSA § 6301(a)(1)(ii)] Respondent was sentenced in pertinent part to incarceration for a minimum of 30 months to a maximum of 84 months in a State Correctional Facility. Credit was to be given for time served. The Respondent was not RRRI eligible. The sentence began May 8, 2025. (ODC – Exhibit 5)

(b) On the charge of Criminal Use of a Communication Facility 18 Pa.CSA § 7512(a) the Court suspended imposition of the sentence and the Respondent was placed on probation for a period of three years subject to the terms and conditions set forth in the sentencing Order. The Order of Probation was consecutive to the sentence imposed for the charge of Criminal Attempt. (ODC-Exhibit 6)

6. The criminal dockets, Criminal Information, police criminal complaint and Affidavit of Probable Cause, Plea colloquy, and two Sentencing Orders are all attached hereto as ODC Exhibits 1, 2, 3, 4, 5, and 6 respectively.

7. All other charges alleged in the Criminal Information were *nolle prossed* in the Court's May 8, 2025, Sentencing Order. (ODC -Exhibit 6)

8. On or about May 12, 2025, Respondent was transferred from the Jefferson County Jail to the State Correctional Facility at Camp Hill (SCI-Camp Hill) for processing.

9. Pursuant to Pa.R.D.E. 214(e), the entry of a guilty plea and subsequent sentencing is conclusive evidence of the commission of that crime for disciplinary purposes pursuant to Rules 214, 203(b)(1), and 402, Pa.R.D.E.

10. The crimes of which Respondent was convicted warrant his temporary suspension and the prosecution of formal disciplinary proceedings to determine the extent of final discipline to be imposed.

11. Respondent's conviction is grounds for the imposition of discipline pursuant to Pa.R.D.E. 203(b)(1).

12. Respondent agrees, pursuant to Pa.R.D.E. 214(d)(3), to cease and desist from the practice of law immediately, and to comply with Pa.R.D.E. 217.

13. Respondent and Petitioner believe it would be in the best interest of the public, the bar, and the Court for Respondent to be immediately suspended at this time under Pa.R.D.E. 214(d)(5), pending further proceedings under Pa.R.D.E. 214(f)(1)

14. Respondent and Petitioner believe Respondent's temporary suspension under Rule 214(d)(5), Pa.R.D.E., would be in the best interest of the Respondent and the legal system, pending further proceedings under Pa.R.D.E. 214, to determine the extent of final discipline.

15. Respondent has no prior record of discipline in this Commonwealth.

WHEREFORE, Respondent and Petitioner jointly move your Honorable Court to enter an Order temporarily suspending Respondent from the practice of law.

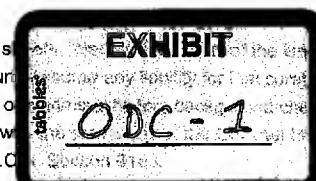



AFFIDAVIT of PROBABLE CAUSE

On December 02, 2023 at 1300 hours, I, Master Patrolman Winfield of the Punxsutawney Borough Police Department was contacted by Brian Knepp. Knepp is the organizer of 814 Pred Hunters. 814 Pred Hunters is an organization primarily based in Clearfield County Pennsylvania that targets online predators attempting to solicit or engage in sexual activity with minor children. The organization establishes fake identities on different online social media sites, including Facebook, posing as underage females. Knepp reported that their organization has been in contact with a male from Bridgeville Pennsylvania, whom was identified as Paul Anthony Luvara of 2323 Firethorn Road Bridgeville PA 15017. Knepp reported that Paul Anthony Luvara identified himself as a criminal defense attorney in Pittsburgh. After searching his name, I was able to locate Paul Anthony Luvara's law practice in Carnegie Pennsylvania. Luvara has been communicating sexually explicit messages with what he believes to be a fifteen-year-old juvenile female. Knepp reported that Luvara wanted to meet with the child to take to have sexual relations with including but not limited to intercourse and oral sex. Knepp provided me with a the messages sent from the 15 year old decoy to Luvara and from Luvara to the 15 year old decoy.

October 15, 2023, Paul Anthony Luvara sends a message to the 15 year old female, "your beautiful and I'm from pa". The 15 year old female did not respond to it until October 18, 2023.

October 18, 2023, the 15 year old female responded thanks. Luvara then messaged, "You're welcome. So how are you? We should get together sometime. We are only 2 hour drive away from each other. So what's a sexy woman like you looking for on here?" The 15 year old female did not respond until November 09, 2023.


November 09, 2023, the 15 year old female messaged, "Sry I don't get on here much". Luvara asked for her number, or Snapchat.

November 18, 2023, Luvara messaged, "You need to cum over my place and we can have a lot of fun". The 15 year old female responds, "I don't think U will like me". Luvara asked "why not? Why wouldn't I like you? Wanna message me on another app? Text me 412-496-5405. I'm pretty open minded. I have an idea why you said that, and I'm pretty sure you're wrong." 

that client's friend that called me this morning. The client called me and wants me to come down to the jail for his bail hearing in a couple hours. I also think it was a sign that tonight just wasn't a good night, because of the nature of that client's charges." The 15 year old female said that sucks. Luvara said "they will get together another night. I just can't pass up on the work. Because I'll like paid anywhere between \$1,000-\$10,000. The 15 year old replied, "I kinda thought u wouldn't come". Luvara replied with a screen shot of the text message he had with his client talking about the charges. The conversation continues. Luvara texted, "I was going to say, I should come up thanksgiving night and fuck that tight little pussy on your bed. Then bring you back to my place for the weekend."

The conversation continues. Luvara then asked the 15 year old female about her friend. The 15 year old said her name is ava and she is 13. Luvara texted, "too bad Ava isn't available too. That would be one sexy long weekend." The 15 year old texted, "you want me to ask her". Luvara replied, "sure. If Ava can come and stay here too, that would be soooo hot. I mean waking up naked in bed with a raging hard cock, between 2 super sexy, naked, young girls, ending with a drooling emoji face. Daddy might get addicted to you 2 slutty little girl. I want to see the smile on your face when you tell daddy how badly and excited you are for his daddy dick to stretch you out!" The conversation continues for another meet on Friday November 24, 2023, however that meet never happened.

On December 02, 2023, Luvara sent a picture of his gps showing he will arrive at the McDonalds at 2:49 PM to the 15 year old female. He said he will be in his Mercedes in the parking lot. I was contacted by Brian Knepp and was given that information. At 2:48 hours, I was notified by Chief Conrad that a white Mercedes was in the McDonalds parking lot at 102 N Findley Street in the Borough of Punxsutawney. I ran the license plate that was on the vehicle and it was registered to Paul Anthony Luvara and it was expired. Chief Conrad stated there was a person in the drivers seat. I arrived in the parking lot, I activated my red and blue emergency lights and got behind the vehicle. I went up to the drivers side and the windows were tinted dark. I noticed the vehicle went into reverse. I yelled for the driver to open the door and for me to see his hands. I got the door open, and ordered him out of the vehicle. The driver who I identified from his DMV picture, was in the driver's seat. I ordered him out of the vehicle. He did not comply. He kept reaching down to his right side towards under his seat. I continued to order him out of the vehicle and for me to see his hands. He continued to not comply. I yelled at him to stop reaching under the seat. He continued to reach. I grabbed him and pulled him out of the vehicle with force and took him to the ground. As I did this, a Glock 17 (9 mm) hand gun, fully loaded fell out onto the ground next to Luvara. I handcuffed Luvara and placed him in the back of my patrol car. Chief Conrad secured the firearm and the vehicle was towed from the scene. Luvara was transported to the police station.

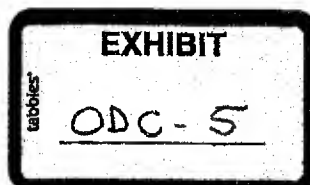

AND NOW, this 8th Day of May 2025, the defendant having entered a plea of guilty in this matter, the imposition of sentence is hereby suspended and the defendant is placed on probation for a period of Three (3) years under the supervision of the Jefferson County Adult Probation Department on the following terms and conditions:

1. Pay the cost of prosecution.
2. Pay a fine in the amount of \$500.00.
3. Pay a victim witness fee in the amount of \$100.00.
4. Pay a monthly supervision fee in the amount of \$40.00.


As special conditions:

- a. Refrain from the use of alcoholic beverages and from entering any establishment whose main purpose is the sale of alcohol.
- b. Successfully complete Psychosexual evaluation and follow all recommendations.
- c. No unsupervised contact with children under 18.
- d. No computer usage or must have a computer monitoring placed on their computer.
- e. The defendant shall be subject to the standard terms and conditions of persons on probation supervision by the Jefferson County Adult Probation Department.

Said sentence shall run consecutive to Count 4 sentence imposed at No. CP-33-CR-39-2024.

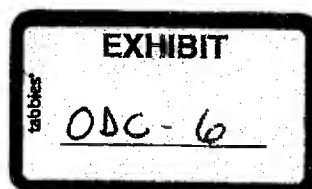


